
2. Token

4. Game


The mobile game sends the player on a space journey in which you can team up with friends, and compete with other players, and at the same time earn money!

5. Tokenomics



Initial Total Supply: 10,000,000,000 PPKAS

Minted Supply: 500,000,000 PPKAS

Minted in batches: 5000 PPKAS

Mint Opportunities: 100,000

1 PPKAS = 0.0002 KAS

Fair launch, no pre-sales. We will announce the date and time for the minting of the PPKAS token in advance. Tokenomics and coin distribution will be as transparent as possible for the community, with addresses holding project tokens publicly disclosed.

Developer shares will begin to unlock gradually 3 months after token deployment.

Tokenomics include deflationary mechanisms and token burning.



Kasplex functions as a fundamental infrastructure for constructing versatile solutions on the Kaspa, enabling easy project launches with a three-part system (Protocol, Indexer, APIs).
